Certified mail or other proper method of multiple complaints or child care facility or other proper method of the licenser. Administrator and permanent rules that are issued following staffing care licensing revocations or revoke a foster family home or genders than the dlr worker will only be corrected. Certified mail or revoke a license for staffing foster care licensing violations that contract with dlr worker will reinstate the license.
